Application Information

RECOAT: Sand with 180 to 220 grit sandpaper along the wood grain until smooth. Remove dust. Finish with *Deft* Clear Wood Finish Brushing Lacquer. Clear Wood Finish Lacquer Sanding Sealer should only be used as a base coat for lacquer finishes.
