DIRECTIONS:

SHAKE WELL for at least one minute after ball rattles. Can temperature should be between 65° and 90° F. Hold can 12 to 14 inches away from surface to be coated. Press spray button firmly. Spray in thin coats to avoid excessive drying times. Wait a few minutes to see if problem is solved before spraying another coat. Clean spray button after use by turning can upside down and pressing spray button until no more product comes out.
